As per our experience, most of the pipeline project takes at least 2 years are required to get all supply front for commissioning. In view of the scenario, we would request you to change payment terms to 90% against dispatch and 10% against completion of Installation & commissioning. Else at least keep a provision to release 10% supply payment by providing additional 10% PBG if commissioning is delaying more than 6months.

Since there are lot of detailing required from hiring of store, security at store, transportation, site work, arrangement of DG & Load bank, necessary civil & mechanical work, therefore we need minimum one month extension of bid submission from the date of receipt of clarification to work out all the details in such remote sites.
