

Point wise reply of your RTI query is as under:

1. The Length & Breadth of the Plot No.76 (under Baligaon village, Bargaon Mouza & Thelamara Revenue Circle) to be acquisitioned are 104.05m & 20m respectively.
2. Area of the Plot No. 76, proposed to be acquisitioned would be around 2,081 Sqm.
3. Amount of compensation would be duly calculated & decided by Competent Authority, Assam, which would be in line with Sub-section-10 of Pipeline & Minerals Pipeline Act, 1962 after assessing the current Market value of land during construction of pipeline.
