**Sub:** **Petroleum and Mineral Pipeline (Acquisition of Right to user in land) Act No 50 of 1962 Information under Section 6 (1).**

**Reference:** As per Notification Extraordinary Gazette No 4216 Dated 31-12-2020 of the Ministry of Petroleum and Natural Gas of the Government of India, in the SO No 4806(E) dated 29-12-2020, the land under the schedule enlisted below – of which you are a recorded land holder – is required in public interest for the laying of the underground pipeline by Indradhanush Gas Grid Limited (IGGL), for the transportation of Natural gas in the State of Assam. Therefore, you are hereby informed that exercising the powers conferred under Sub Section (1) of the Section 6 of the Petroleum and Mineral Pipeline (Acquisition of Right of User in Land) Act, 1962 the Right of User over the scheduled land, has been acquired by the Central Government for the purpose cited above – vide the aforementioned Notification.

Even after acquisition of the right of user over the scheduled land, you will retain your Land-holding rights over that land. However, according to the Section 9 of the Petroleum and Mineral Pipeline (Acquisition of Right of User in Land) Act, 1962, construction of any building or any other structure; or construction or excavation of any well, tank, reservoir or dam; or plantation of any trees on that scheduled land shall be strictly prohibited.

You have been notified of these implications before as per the provision of Section 3(1) of the Petroleum and Mineral Pipeline Act, 1962. The construction of the pipelines can now start any time soon.

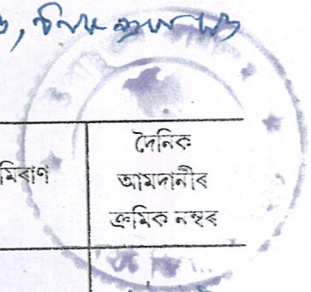
