Sir,

With reference to the subject above, we desire the information from your office as given below:

1. What is the main objective of Indradhanush Gas Grid Limited for laying the gas pipeline from our state?

Response: Indradhanush Gas Grid Limited has been entrusted by the Ministry of Petroleum & Natural Gas (MoP&NG, Government of India) to develop 1656 Km long North East Gas Grid (NEGG) Pipeline, in line with Hydrocarbon Vision 2030 for Northeast India, for leveraging the region's Hydrocarbon potential, enhancing access to clean fuel and upliftment of Socio-economic growth of entire North-East including Meghalaya.

2. Whether the sanctioned scheme for the benefit mainly to the people of Meghalaya or Assam? Please furnish the Detailed Project Report (DPR) of this project and under whether the scheme sanctioned by Meghalaya, Assam or Central Government

Response: The project is aimed for socio-economic benefit of larger sections of the society of all north-eastern states including Meghalaya. The Project is undertaken under Hydrocarbon Vision 2030, which can be referred to website of IGGL(www.iggl.co.in). However, the DPR cannot be shared, except with the statutory authorities only. The Project has been sanctioned by Government of India on 08.01.2020 and authorized by Petroleum & Natural Gas Regulatory Board (PNGRB) under Government of India on 17.11.2020.

3. Who will be benefit from this project, the people of Meghalaya or Assam and what are the benefits of the people would get?

Response: The Natural Gas will be available for supply to the Domestic households, Compressed Natural Gas (CNG) for vehicles, Industries (both present and future), Commercial establishments in all the 8 (eight) states of Northeast including the State of Meghalaya, which is more clean, eco-friendly and economic fuel, which will definitely uplift the socio-economic development of the state and benefits the society, as a whole.

4. Furnish the copy of NOCs from Syiem (Traditional Chief), Dorbar Shnong (Village Committee) and JHADC (Jaintia Hills District Council) for implementation of the project works.

Response: IGGL have already applied NOC to all the concerned Syiem (Traditional Chief), Dorbar Shnong (Village Committee) and JHADC (Jaintia Hills District Council)

for implementation of the project works under their respective jurisdiction which is already in advance stage of obtaining NOC for the same.

5. When was the public hearing conducted for this project in Jaintia Hills? Furnish the copy of attendee presented in the hearing and its outcome? When and which newspaper was published for the conduct of hearing, please furnish the copy of the same.

Response: The Competent Authority (IGGL-Meghalaya), empowered under Petroleum & Mineral Pipeline (PMP) Act 1962 & its amendments, has arranged awareness programme cum hearing of objections with the affected landowners on 17.01.2022, 18.01.2022, 28.01.2022, 29.01.2022 in Jaintia Hills, after serving of 3(1) notifications to the affected landowners as per the referred Act, in the presence of the representatives of District Administration and Headman of the concerned village.

Attendance sheet of the attendees, presented in the hearing, are available with the office of the Competent Authority (IGGL-Meghalaya). The outcome of the meeting is that land owners were agreed and cooperating for successful implementation of the Project and sustainability environmental development.

Publication in Newspaper for hearing of objection of the affected landowners does not arise, as per provisions of section 5 of PMP Act.

6. Please furnish the list of the villages and affected landowners would be passing by the gas pipeline? What is the area would be acquired by IGGL, land rate to be paid per square foot and other rates for different plants and products. Whether the land compensation have been paid or not?

Response: List of notified villages, enroute by NEGG pipeline, for RoU (Right of User) acquisition are available in Gazette of India (www.egazette.nic.in) and IGGL (www.iggl.co.in) including the areas. Village-wise affected landowners, land rates and other rates for different plants and products are available with the office of the Competent Authority (IGGL-Meghalaya).
