No.PEM.130/2021/40,- In exercise of the powers conferred by the sub-section (1) of section 15 and section 23C of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act 67 of 1957), the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Minor Mineral Concession Rules, 2013, hereinafter referred to as the principal Rules, in the manner hereinafter appearing, namely:-

(Amendment) Rules, 2021.

Short title and 1. (1) commencement

Amendment of 2. rule 5 They shall come into force on the date of their publication in the Official Gazette.

In the principal Rules, in Rule 5, for the existing the sub-rule (3), the following shall be substituted, namely: -

These rules may be called the Assam Minor Mineral Concession

" (3) (1) - The minor minerals, when shall be used or consumed by Government Departments, the rates of Royalties shall be paid as per the rates prescribed in the Third Schedule appended to these rules and other Ancillary Charges as shall be notified by Government, shall be deducted by the Government Departments through the Treasury in proportionate rate to the percentage of the total cost of project excluding taxes as GST, IT etc..

The minor minerals, when shall be used or consumed by Government Agencies the rates of Royalties shall be deducted as par the rates prescribed in the Third Schedule appended to these roles and other Ancillary Charges as shall be notified by Government, at the time of payment of bills of contractors or suppliers in proportionate rate to the percentage of the total

The Royalties as collected by the Urban Local Bodies shall be deposited the Head of Account or Bank account as shall be notified by the Government.

In rural areas, the existing procedure of making payments of Royalties shall continue.

(iv)The rates as appended in the Third Schedule and process as prescribed above shall be applicable to fresh tenders only."
