This is with reference to your RTI Ref. No.: Nil, dtd. 10/01/2024, received on dtd. 16/01/2024, the replies to your queries are as follows:

1	Kindly refer to speaking order of Govt of Assam, Office of the Deputy Commissioner, Sonitpur, Tezpur (Land acquisition Branch) LA-26/93/2023-LAQ-SON, Memo No. SRA-2/2023 dated 12 Jun 2023 (copy enclosed). It is found that all the neighbour villages like Kurukani, Dikraijan, Singitoli and Khalihamari considered the fixation of maximum prevailing market value (as per considering your letter 3 (b) above) except the village <u>Pungpani Bangali</u> which is the next border line with village Khalihamari i.e., same zonal valuation of land where IGGL pipeline project is under process.	A) Whereas the right of user in land in some portion of Pugnani Bangali village was acquired by publication 6(1) Gazette Notification Gazette ID No. ID-CG-DE-E-12012021 and the market value of land for calculation compensation is declared in the same year by the Deputy Commissioner, vide speaking order No. SRA 02/2021/405 dated 22/10/2021.  B) Whereas the right of user in land in the village Kurukani, Dikraijan, Singitoli and Kalahari was acquired in Feb 2023 vide gazette ID CG-DE-20022023-243753 and the land rate for the area was declared by the Deputy Commissioner vide LA-26/93/2023-LAQ-SON, Memo No. SRA-2/2023 dated 12 Jun 2023.
