Invitation to Offer Natural Gas / RLNG

Indradhanush Gas Grid Limited is pleased to invite offers from prospective Sellers to supply 3.1 MMSCM at a pressure of 35kg/cm² of Natural Gas ("Gas") commencing from 2nd fortnight of July 2025. The gas is intended to be used for line pack of the Guwahati Numaligarh Pipeline section of Northeast East Gas Grid (NEGG).

3.	Commencement of Gas Supplies	Gas supplies shall commence in the 2nd fortnight of July 2025
4.	Period	Tentatively on 4 th week of July 2025 (Total approx. 20 days considering daily requirements of approx. 0.16 MMSCMD)
5.	Delivery Point	GAIL & IGGL interconnection at Baihata, Assam in the North-East Gas Grid (NEGG) of IGGL. It will be Bidder's responsibility to execute GTA and CTA for transportation of the gas up to injection point of NEGG, i.e. Baihata, Assam.

9.	Point of Injection of Gas	Bidder to specify point of injection of gas in National Gas Grid. This information is required for determining transportation tariff applicable under Unified Tariff of PNGRB for calculating landed cost at Dispatch Terminal at Baihata in Assam.

The password of ZIP File 2 (Price Bid) will be shared by the qualified bidders during the VC and price bids shall be opened in presence of all the qualified bidders and the nominated officers from Finance, Marketing and Project of IGGL. After opening the price bid of the successful bidders, evaluation of the bids will be done on the basis of the overall lowest landed cost of Natural Gas at IGGL designated receiving point as per tender.
