Sub: Request for permission to hang Notice at Office Notice Board for inviting objection, from interested parties, against disbursal of compensation to identified beneficiary of land falling within IGGL RoU.

Sir,

As you are aware that Indradhanush Gas Grid Limited (IGGL), a Joint Venture of 5 (five) prestigious Public Sector Undertaking Companies i.e., IOCL, ONGC, GAIL, OIL & NRL, is executing the prestigious North East Gas Grid Project. The pipeline grid would connect to State capitals of all States of North Eastern part of India i.e., Assam, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Tripura & Sikkim.

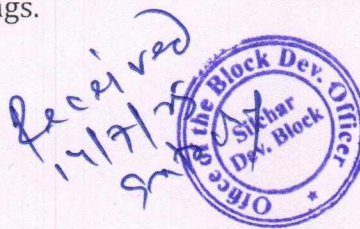
For laying of Silchar-Banskandi Pipeline in Cachar District, the Right of Use (RoU) of land is being acquired as per the provisions of Petroleum and Minerals Pipeline Act, 1962. The details of land falling within the RoU of IGGL was published in Gazette under section 3(1) and 6(1) of the P&MP Act, 1962. As per Section 10 & 11 of the said Act, IGGL has to pay compensation for Land, Crop, Zirat, etc. to affected beneficiaries.

- 1) For identifying beneficiaries for land Compensation, Punchnama was carried out in **Bagpur Part-II and Bagpur Part-I villages** and land possessors were identified in presence of Lot Mandals authorized by your kind office. A possessor becomes the beneficiary if the possessor is the sole owner (as per chitta-copy/RoR of land) of the concerned part of Dag of Land.
- 2) As Cachar District is undergoing settlement process, the Pipeline RoU affected land holders are required to produce Provisional Mutation Certificate provided from your office, after which a notice inviting objections about disbursal of compensation against identified beneficiary is to be hung at your office by the process of **Latkejari**. As such we are attaching herewith a notice along with the list of Dags, Pattadars and respective beneficiaries of **Bagpur Part-II and Bagpur Part-I villages under Sonai Circle**, that need to be hanged for 15 days in the Notice Board of your kind office.

We request you to accord your permission to hang the notice at your office's notice board and also to direct your good office for collection of objections and forward objection received status after 15 days of notice period. Further you are requested to arrange for verification of the objections also.

Also, a 'No Objection Received' certificate is to be issued from your kind office, if at the end of 15 days no objections are received post Latkejari for the listed Dags.

LATKAJARI PUBLIC NOTICE

It is hereby informed that the Banskandi Feeder Gas Pipeline, being laid by Indradhanush Gas Grid Limited (IGGL), passes through **Sonai Revenue Circle** villages: **Bagpur Part-II and Bagpur Part-I** under Cachar district. The necessary Right of User (RoU) for this gas pipeline has been acquired by the Government of India (Ministry of Petroleum and Natural Gas) in exercise of the powers conferred by the Petroleum and Minerals Pipelines (Acquisition of Right of User in Land) Act, 1962, vide Gazette Notifications **S.O.No. 1322(E) Dated. 16th March, 2023, S.O. 3323(E). Dated 18th July, 2023, S.O. No. 4415(E) Dated. 05th December, 2019 and S.O. 4499(E). 19th September, 2022**

Prior to land compensation disbursement to landowners as per P&MP Act 1962, field assessment survey and subsequent punchanama activities have been carried out to identify landowners possessing land within the pipeline RoU. After survey/measurement, the pipeline RoU has been found passing through the lands of the identified landowners whose names, respective Dag Nos, pipeline RoU affected area are mentioned in the Annexed List.

Since villages of Cachar District are under settlement process, 'Provisional Mutation Certificate' is being issued by respective Settlement Offices wherever mismatch is observed in the names of identified landowners with the Record of Rights.

During field assessment, it has been observed that apart from the identified landowners possessing land within the pipeline RoU, names of some other co-pattadars are also present in the Record of Rights, although their land possession have not been found within pipeline RoU. 'Hanging Public Notice' procedure or 'Latkajari Public Notice' of said Dags is done for 15 days to invite objections prior to land compensation disbursement to the identified landowners. Objections, if any, from other asjmalis co-pattadars are to be submitted at **Sonai Revenue Circle Settlement Office** or at the office of Indradhanush Gas Grid Limited (IGGL) within 15 days of issue of this 'Latkajari Public Notice'.
