Sub: Permission for hanging Notice at Notice Board for inviting objection about disbursal of compensation to identified beneficiary from person interested in the part of Land falling in IGGL ROU.

Ma'am,

As you are aware that, Indradhanush Gas Grid Limited (IGGL), a Joint venture of 5 (five) prestigious Public Sector Undertaking Companies i.e., IOCL, ONGC, GAIL, OIL & NRL is executing North East Gas Grid (NEGG) Project. The pipeline grid would connect to State capitals of all States of North Eastern part of India i.e., Assam, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Tripura & Sikkim.

For laying of Silchar-Banskandi Pipeline, The Right of Use (RoU) of land is being acquired as per the provisions of Petroleum and Minerals Pipeline Act (P&MP Act, 1962). The details of land falling under RoU was published in Gazette under section 3(1) and 6(1) of the P&MP Act, 1962. Under provisions of Section 10 & 11 of the said Act, IGGL has to pay compensation for affected Land, Crop & Zirat etc.

For identifying beneficiaries of land compensation, Panchnama was carried out in which possessor was identified in presence of LM. The possessor becomes beneficiary if the possessor is the sole owner (as per chitta copy of land) of the part of Dag of Land.

As Cachar District is undergoing settlement process and the Pipeline affected landholders are required to produce Provisional Mutation Certificate (PMC) provided by your office, after which a notice inviting objections about disbursal of compensation against identified beneficiary is to be hung at your office by the process of Latkajari. As such we are attaching herewith a notice along with the list of Dag, Pattadars and beneficiaries of the **villages Niz-Banskandi Pt-3 and Gobindapur Pt-3** under **Sonai Circle** that need to be hanged for 15 days at the Notice Board.

We request you accord your permission to hang the notice on your office's notice board and direct your good office for the collection of objections and forward the objection received status after 15 days of notice period. Further, you are requested to arrange for verification of the objections also.

Also a "No Objection Received" certificate is to be issued from your kind office if at the end of 15 days no objections are received post Latkajari for the listed Dags.

You are hereby informed that the proposed Gas Pipeline of Silchar Banskandi Feeder Gas Pipeline Project will be laid through Sonai Revenue Circle villages: **Niz-Banskandi Pt-3 & Gobindapur Pt-3** under Cachar district, the necessary right of use for this gas pipeline has been granted by the Ministry of Petroleum and Natural Gas of India under P&MP Act 1962, Gazette Notification S.O No. 4415(E) dt 5th Dec 2019 & S.O No. 3152(E) dt. 6th July 2022.

The pipeline passes through the lands of the spotted land owners whose names are given on the annexed list. Therefore, the pipeline-affected area of the beneficiaries named in the list of affected dags has been expressed in square meters after survey/measurement.

For disbursement of land compensation, "Provisional Mutation Certificate" will be issued by the concerned Circle Office for villages under settlement process in Cachar district where, mismatch will be observed with the identified owner's name and Record of Rights. Again, for plots with multiple tenants, No Objection (NOC) is required from co-tenants or legal heirs.

"Hanging notice" method or "latkajari" of the said spots or objections before disbursement of compensation in any other case and if there is any strong objection by other asjmali Pattadars to recovery of compensation value of affected Pattadars under the Land Acquisition Act, objections to be submitted at Sonai Revenue Circle Settlement Office within 15 days of issue of this notice or representative office of Indradhanush Gas Grid Limited (IGGL), which is responsible for laying the proposed gas pipeline.

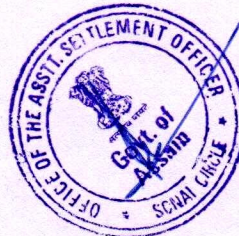

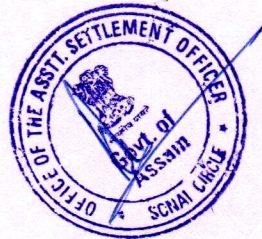
