Sub: Request for permission of hanging Notice at Notice Board for inviting objection about disbursal of compensation to identified beneficiary from person interested in the part of Land falling IGGL ROU.

Sir,

As you are aware that, Indradhanush Gas Grid Limited (IGGL) a Joint venture of 5 (five) prestigious Public Sector Undertaking Companies i.e., IOCL, ONGC, GAIL, OIL & NRL is executing North East Gas Grid Project. The pipeline grid would connect to State capitals of all States of North Eastern part of India i.e., Assam, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Tripura & Sikkim.

For laying of Silchar Banskandi Pipeline, The Right of Use (RoU) of land is being acquired as per the provisions of Petroleum and Minerals Pipeline Act (P&MP Act, 1962). The details of land falling under RoU was published in Gazette under section 3(1) and 6(1) of the P&MP Act, 1962. Under provisions of Section 10 & 11 of the said Act, IGGL has to pay compensation for affected Land, Crop & Zirat etc.

For identifying beneficiary of land Compensation, Punchnama was carried out in which possessor was identified in presence of LM. The possessor becomes beneficiary if the possessor is the sole owner (as per chitta copy of land) of the part of Dag of Land.

As Cachar District is undergoing settlement process and the Pipeline affected land holders are required to produce Provisional Mutation Certificate provided from your office after which a notice inviting objections about disbursal of compensation against identified beneficiary is to be hung at your office by the process of Latkajari. As such we are attaching herewith a notice along with the list of Dag, Pattadars and beneficiaries of the village **Durgapur** under **Silchar Circle** that need to be hanged for **15 days** at the Notice Board.

We request you to accord your permission to hang the notice at your office's notice board and direct your good office for collection of objections and forward objection received status after 15 days of notice period. Further you are requested to arrange for verification of the objections also.

Also a **"No Objection Received"** certificate is to be issued from your kind office if at the end of **15 days** no objections are received post Latkajari for the listed dags.

It is hereby informed that the Banskandi Feeder Gas Pipeline, being laid by Indradhanush Gas Grid Limited (IGGL), passes through **Silchar Revenue Circle** village: **Durgapur**, among other villages in Cachar district. The necessary Right of User (RoU) for this gas pipeline has been acquired by the Government of India (Ministry of Petroleum and Natural Gas) in exercise of the powers conferred by the Petroleum and Minerals Pipelines (Acquisition of Right of User in Land) Act, 1962, vide Gazette Notifications S.O No. 4415(E) dt 5th Dec 2019 & S.O No. 1817(E) dt. 13th April 2022.

After survey/measurement, the pipeline RoU has been found passing through the lands of the identified possessors whose names, respective Dag Nos, pipeline RoU affected area are mentioned in the Annexed List.

For land compensation disbursement in villages of Cachar District under settlement process, 'Provisional Mutation Certificate' is being issued by respective Settlement Offices where mismatch is observed in the names of identified possessor with the Record of Rights.

For land compensation disbursement to identified possessors in Dags having multiple co-pattadars, NOC is required either from co-pattadars or from their legal heirs in their absence. Alternatively, 'Hanging Notice' procedure or 'Latkejari' of said Dags is done for 15 days to invite objections prior to land compensation disbursement to the identified possessors. Objections, if any, from other asjmalis co-pattadars are to be submitted at Silchar Revenue Circle Settlement Office or at the office of Indradhanush Gas Grid Limited (IGGL) within 15 days of issue of this notice.
