Sub: Request for permission of hanging Notice at Notice Board for inviting objection about disbursement of compensation to identified beneficiary from person interested in the part of Land falling IGGL ROU.

Sir,

In line with Hydrocarbon vision 2030 the ministry of Petroleum and Natural Gas is planning to connect all the state capitals of 8 North Eastern states with the national gas grid by laying 18" dia. gas pipeline. The execution of the same is being carried out by IGGL, a JV of India's five major OIL & GAS PSUs namely OIL, ONGCL, GAIL, NRL and IOCL.

For laying of pipeline, the Right of Use (RoU) of land is being acquired as per the provisions of Petroleum and Minerals Pipeline Act (P&MP Act, 1962). The details of land falling under RoU was published in Gazette under section 3(1) and 6(1) of the P&MP Act, 1962.

Under provisions of Section 10 & 11 of the said Act, IGGL has to pay compensation for affected Land, Crop & Zirat etc.

For identifying beneficiary of land Compensation, Panchnama was carried out in which possessor was identified in presence of Gaon Burha, LM etc. The possessor becomes beneficiary if the possessor is the sole owner (as per chittha copy of land) of the part of Dag of Land. In case of multiple pattadars, the possessor should be one of their corded pattadars and have to produce NOC from other co-pattadars having right on the Dag of Land. In case of death of the recorded pattadars, the possessor has to produce NOC from co-pattadars as well as from heir of the deceased pattadars as per family tree.

It has been found that, in some cases identified possessor of land could not produce No Objection Certificate from co-pattadars or their heir due to non-traceability or change in residence location. To inform the interested person in land we are adopting "Hanging Notice" procedure to invite objection about disbursement of compensation against identified beneficiary.

As such, we are attaching herewith a notice along with list of Dag, Pattadars and beneficiary of the villages **Khelma Pt-II, Khelma Pt-III, Niz-Jalalpur Pt-I, Saraspur, Biswambarpur, Chandinagar Pt-4 & Natanpur** and that need to be hanged for 15 days at the Notice Board.
